Because subjects and verbs are either singular or plural, the subject of a sentence and the verb of a sentence must agree with each other in number. That is, a singular subject belongs with a singular verb form, and a plural subject belongs with a plural verb form.

2.2 Subject-Verb Agreement – Writing for Success

In reading, a good read is one whose flow and diction are smooth. The perfect subject-verb agreement aids this. In other words, it means both the subject and the verb must agree in numbers. If the subject is singular, then the verb must be singular too, or if one is plural, then another one must be plural also. All the best as you test yourself.
