Prices of foreign exchange options are often given in terms of their implied volatilities, as calculated by the Garman-Kohlhagen model. The Garman-Kohlhagen model is similar to the model developed by Merton to price options on dividend-paying stocks, but allows borrowing and lending to occur at different rates. Additionally, the underlying exchange rate is assumed to follow Geometric Brownian Motion, and the option can only be exercised at maturity.

Premium – The upfront cost of purchasing a currency exchange option. Strike Price – The strike (or exercise price) is the price at which the option holder has the right to buy or sell a currency. Expiry Date – The trade's expiry date is the last date on which the rights attached to an option may be exercised.

In addition to having their prices determined by supply and demand on exchanges like the Chicago IMM and PHLX exchanges, currency options can be theoretically priced using a modified mathematical pricing model based on the traditional Black Scholes option pricing model that had been developed to price stock options. This pricing model for currency options is known as the Garman Kohlhagen model after researchers named Garman and Kohlhagen modified the Black Scholes model in 1983 to take into ...

The issue here is that all your rates are expected to be in units of domestic vs 1 unit of foreign. So for example USDCAD is 1.3347, you really need to be using $1/1.3347 = 0.749$ USD per 1 CAD. So, your inputs need to be $S = 1 / 1.3347$ $X = 1 / 1.3338$ $R_d = 0.75\%$ $R_f = 0.50\%$ $r = 6.55\%$ $T = 22 / 252$

Put option – the right to sell an asset at a fixed date and price. Foreign exchange option – the right to sell money in one currency and buy money in another currency at a fixed date and rate. Strike price – the asset price at which the investor can exercise an option. Spot price – the price of the asset at the time of the trade. Forward price – the price of the asset for delivery at a future time.
