To figure out if you qualify for food stamps, Maryland needs to know your:

Household size: How many people you live and buy/make food with. Income: How much money your household makes. This includes both earned income (the money you make from jobs) and unearned income (cash assistance, Social Security, unemployment insurance, and child support, etc.).

Food Stamp Eligibility in Maryland | Fresh EBT

The following deductions are allowed for all households: standard deduction; 20 percent of earned income; actual costs of dependent care costs for children and disabled adults if this care is needed so that a household member can work, look for a job, or get training or education leading to a job;

## Food Stamps Eligibility - SNAP Program Eligibility Help

Currently, households may have \$2,250 in countable resources (such as cash or money in a bank account) or \$3,500 in countable resources if at least one member of the household is age 60 or older, or is disabled. These amounts are updated annually.

## SNAP Eligibility | USDA-FNS

The following deductions are allowed for SNAP: A 20-percent deduction from earned income. A standard deduction of \$167 for household sizes of 1 to 3 people and \$181 for a household size of 4 (higher for some larger households and for households in Alaska, Hawaii, and Guam). A dependent care deduction when needed for work, training, or education.
