The article title appears in plain text and sentence case, while the journal name is italicized and in title case (all major words capitalized).

Sample Papers - APA Style

Basic Format: Last name, A. A. (Year). Title of article. Title of Journal, Volume number (issue number if available), pages.
Example: Scruton, R. (1996). The eclipse of listening. *The New Criterion*, 15(3), 5-13.
Note: The name of the author is reversed with the last name first followed by the initials.

APA Journal Citation | APA Format

If a journal article has a DOI, include the DOI in the reference. Always include the issue number for a journal article. If the journal article does not have a DOI and is from an academic research database, end the reference after the page range (for an explanation of why, see the database information page).
The reference in this case is the same as for a print journal article.

How to Cite a Journal Article in Print or Online in APA Format. Articles differ from book citations in that the publisher and publisher location are not included. For journal articles, these are replaced with the journal title, volume number, issue number and page number. The basic structure is: Journal Article Examples: Mitchell, J.A. (2017).

Note: All citations should be double spaced and have a hanging indent in a Reference List. A "hanging indent" means that each subsequent line after the first line of your citation should be indented by 0.5 inches. For an APA citation journal article from a database, you are not required to include the database information. This is because APA format includes a link to the website or the DOI instead, since database information can change over time. Simply follow the format for an APA citation journal from online as described above. Published May 9, 2019.

How to Cite a Journal in APA | EasyBib Citations

Start by citing the article according to APA style. Begin with the last name (s) and initial (s) of the author (s). This is followed by the year of publication in parentheses. The article name comes next, followed by the title of the journal (in italics), volume number (in italics) and issue number in parentheses.
